The Court, having entered its Bifurcated Findings of Fact and Conclusions of Law, and good cause appearing therefore, now hereby **ORDERS, ADJUDGES, AND DECREES** as follows:

1. A *Bifurcated Decree of Divorce* is hereby granted and entered to the Respondent forever dissolving the marital relationship and bonds between the parties.
2. This *Bifurcated Decree of Divorce* dissolves the parties' marriage but all remaining issues shall remain as status quo and are hereby reserved for further adjudication without prejudice to either party.

3. The date of the valuation of the parties' real property shall be reserved for trial and the date of bifurcation will not necessarily be the date of the valuation of the real property given the nature of Respondent's special request for bifurcation of these proceedings.

4. Counsel for the parties are admonished to comply with their ethical duty to respond to communications from opposing counsel.
