Based upon the Order Granting Motion to Renew Judgment that was entered in the above-captioned matter IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

1. The Judgment previously entered in this matter on June 6, 2018 is hereby renewed in favor of the Plaintiff and against Defendant Arthur L. Herbst (the “Defendant”), is hereby renewed;

2. The current amount owing under the Judgment through June 6, 2026, is \$91,878.44, which consists of:

- a. the principal balance of \$13,507.05 for Note I;
- b. the principal balance of \$14,834.50 for Note II;

- c. the principal balance of \$16,961.52 for the Visa Card
- d. accrued interest of \$3,605.24 from March 13, 2018 through June 6, 2026 on Note I;
- e. accrued interest of \$10, 693.54 from March 13, 2018 through June 6, 2026 on Note II;
- f. accrued interest of \$16,628.47 from March 13, 2018 through June 6, 2026 on the Visa Card;
- g. plus attorney's fees \$1,091.00 and costs of \$499.05 awarded at judgment; and
- h. plus attorney's fees of \$2,897.00 and costs of \$11,160.97 incurred from March 13, 2018 to June 6, 2026.

3. Interest shall continue to accrue on the principal amounts at the contractual rates of 3.24% under Note I, 8.75% under Note II, and 11.9% under the Visa Card from June 6, 2026, until paid in full; and

4. This judgment may be augmented in the amount of reasonable costs and attorney's fees expended in collecting the judgment by execution or otherwise.
