2. Contract Damages/Liquidated Damages in the amount of \$282,864.18.
3. Pre-judgment interest in the amount of \$16,274.16.

4. Collection fees in the sum of \$176,790.51.
5. Attorney fees per the contract in an amount to be augmented by affidavit.
6. The judgment amount of \$1,183,090.90 herein shall hereafter bear interest on the whole thereof at the statutory rate of 10%.
7. This judgment may be augmented pursuant to the Utah Rules of Civil Procedure, to include 1costs and reasonable attorney's fees expended in collecting said judgment by execution or otherwise, as shall be established by affidavit.
