Divorce

c.

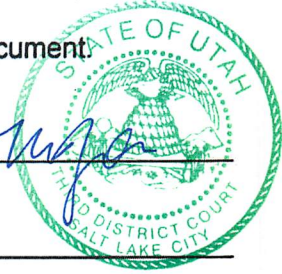

From the date of this agreement forward, neither party shall incur any debt in the other's name, or in their joint names, and any such debt shall be the sole responsibility of the party who incurred it.

Duty to sign documents

10. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)

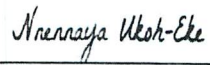
