The above-captioned matter having come before the above-referenced Court, the Court having reviewed the file and finding the necessary pleadings in the file, the Court having entered its Findings of Fact and Conclusions of Law, and being otherwise fully advised states:

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED:

Provisions Relating to Termination of Marriage

1. Adrienne and Robert were married in Springville, Utah, on February 16, 2015.
2. Adrienne is awarded a divorce from Robert on the grounds of irreconcilable differences and the marriage is hereby terminated.

Provisions Relating to Minor Children

3. The parties have children none of which are minors. No minor children are expected.

Provisions Relating to Alimony

4. Both parties are able to support themselves and are not in need of alimony. Alimony shall be waived by both parties now and forever in the future.

Provisions Relating to Real Property

5. The real property of concern is located at 1566 W. 4800 S. Taylorsville, UT 84123.

6. The parties agree that Robert should keep this property free and clear of any claim by Adrienne so long as he follows the due dates below.

7. Robert agrees to get her name off the loan and all other necessary documents within sixty (60) days from the Decree of Divorce or the house will immediately be listed for sale.

a The parties will make no repairs and the parties agree to use the listing agent's opinion on all price drops, accepting of offers, or other needs in selling the residence.

Provisions Relating to Personal Property

8. Each party shall be awarded their own separate personal property that they acquired before their marriage.

9. Adrienne shall be awarded the 2022 Nissan Pathfinder.

10. Robert shall be awarded the 2022 Chevrolet Silverado.

a. Robert shall also be awarded the 2022 Razor Turbo R4 Ultimate. Robert agrees to remove Adrienne's name from the loan on this vehicle within sixty (60) days of the date of this agreement.

b. Robert shall also be awarded Ducati Motorcycle and Dirt Bike

11. All other personal property acquired during the marriage should be divided as the parties have already divided it.

Provisions Relating to Financial/Bank Accounts

12. Adrienne made payments on the Razor listed above in the amount of \$2,900.00. This will be paid back to Adrienne within 60 days of the signing of the divorce through financial accounts or otherwise.

13. The parties do not have any joint bank accounts. If any are discovered, they should be awarded 50/50 to each party.

14. Each party shall keep all accounts in their own name free and clear of any claim by the other party.

Provisions Relating to Investment Accounts and Retirement Accounts

15. The parties agree to keep their own retirement and investment accounts free and clear of any claim by the other party.

Provisions Relating to Debts

16. Each party is solely responsible for the debt that they have incurred in their own name since the date of this agreement. Neither party shall have claim against the other for debt that is solely in their own name.

17. The parties agree not to incur any additional debt in the other party's name now or forever in the future.

18. The parties have IRS tax debt. Robert agrees to pay off this debt within six (6) months of the date of the Decree of Divorce and hold Adrienne harmless therefrom. Adrienne is walking away from an equity in the real property if he handles this liability.

a. Robert agrees to provide Adrienne with a monthly statement via email in order for Adrienne to track the progress of the debt being paid.

Provisions Relating to Taxes

19. Adrienne and Robert will file taxes together for 2025. If there is any refund available, the parties agree to split it equally. If there is any tax liability from 2025, Robert and Adrienne agree to be responsible for that tax liability 50/50.

Provisions Relating to Attorney's Fees and Costs

20. The parties should each pay their own attorney's fees and costs incurred in prosecuting this action.

Miscellaneous Provisions

21. Adrienne will be restored to her name of Adrienne Butler if she so desires.

22. Each party is ordered to execute and deliver to the other such documents as are required to implement the provisions of the Decree of Divorce entered by the Court.
