HEREBY FINDS, ORDERS, ADJUDGES AND DECREES THAT:

1. On 7/18/2018 the Court entered Judgment in favor of Plaintiff in the amount of \$1,805.80 at 2.41% Post-Judgment Interest plus accruing Post-Judgment Costs expended in the collection of the Judgment.
2. The following interest, costs, and/or credits have accrued since entry of Judgment:
