The Utah Supreme Court's October 17, 2025 opinion in *Farm Bureau Mutual Ins. Co. v. Weston*, 2025 UT 42, 587 P.3d 936, vacated judgment in favor of Farm Bureau and, as a result, made Farmers Insurance Exchange the prevailing party in both the appeal and the litigation. Farmers moved for costs pursuant to rule 34(a) of the Utah Rules of Appellate Procedure.

Following briefing, on June 5, 2026, the Court ruled that Farmers is entitled to judgment against Farm Bureau for \$6,479.15 as the prevailing party on appeal.

Accordingly, judgment is hereby entered in favor of Farmers Insurance Exchange against Farm Bureau Mutual Insurance Company in the amount of \$6,479.15.
