This matter having come before the Court on Petitioners' Motion for Summary Judgment; the Court having issued its Ruling on that Motion on June 25, 2026 (the "**Order**") (Dkt. No. 101), granting summary judgment in favor of Petitioners Jon Zwahlen, Artumus Esplin, and Blake Rayl (collectively, "**Petitioners**") and against Respondents LaDawn Rice Zwahlen ("**LaDawn**") and Jody Lee Zwahlen ("**Jody**") (collectively, "**Respondents**") on all claims; the Order being incorporated herein by reference as though fully set forth; and no claims remaining before the Court; now, pursuant to the Order, and good cause appearing,

**IT IS HEREBY ORDERED, ADJUDGED, AND DECREED as follows:**

1. Final judgment is entered in favor of Petitioners and against Respondents on all causes of action asserted in the Petition (Breach of Fiduciary Duty, Conversion, Fraud, Conspiracy to

Commit Fraud and Conversion, Unjust Enrichment, and Disqualification of Jody Lee Zwahlen as Successor Trustee Under Utah's Uniform Trust Code).

2. Petitioners are awarded a money judgment against Respondents, jointly and severally, in the amount of **\$43,260.10**, consisting of:

- a. \$34,000.13 in principal, representing the improperly diverted Trust funds.
- b. \$9,259.97 in prejudgment interest, awarded pursuant to Utah Code § 15-1-1(2) at a rate of 10%, calculated on a per-payment basis from the date each of the 102 individual diverted payments was made through June 30, 2026.

3. Post-Judgment Interest. Post-judgment interest shall accrue on the total judgment amount of \$43,260.10 at the rate of 5.51% per annum pursuant to Utah Code § 15-1-4(3)(a), from the date of entry of this Judgment until paid in full.

4. Declaratory Judgment — Disqualification of Jody Lee Zwahlen. Declaratory judgment is entered disqualifying Jody Lee Zwahlen from serving as successor trustee of the Mary Dawn Rice Family Trust, the Trust for LaDawn Rice Zwahlen, the Trust for LaRae Rice, or any related sub-trust created thereunder. Jody Lee Zwahlen is deemed unfit to serve in any fiduciary capacity with respect to any assets of the foregoing trusts.

5. The final judgment may be supplemented and augmented by additional interest, attorneys' fees, costs, and expenses incurred by Petitioners, including those incurred during collection, enforcement, or appeal of this Judgment.

This is a final judgment, the claims of all parties having been considered, ruled upon, or dismissed. No claims of either party are outstanding, and no further order is required.
