THIS MATTER came before the Court by way of Petitioner Victoria Michelle Mott's ("Ms. Mott") and Respondent Jason Jacob Mott's ("Mr. Mott") Bifurcated Decree of Divorce entered on January 23, 2026, by the Honorable Judge James Gardner. The Court having reviewed the Bifurcated Decree of Divorce and the relevant facts and law, hereby makes and enters the following JUDGMENT AND ORDER:

IT IS HEREBY FOUND that:

1. A Bifurcated Decree of Divorce (“Bifurcated Decree”) was entered in this matter on January 23, 2026.

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED, as follows:

2. Pursuant to ¶ 11 of the Bifurcated Decree, Judgment is hereby entered in favor of Ms. Mott against Mr. Mott as follows:

a. Financial Judgment

i. Ms. Mott is entitled to judgment against Mr. Mott as follows:

1. Financial Judgment: \$11,420.00, representing the disparity in the division of the parties’ financial accounts as awarded in the Bifurcated Decree. (*see docket entry 46, ¶ 11*)

b. Judgment Amount:

i. Ms. Mott is awarded a Judgment and Order against Mr. Mott in the total amount of **\$11,420.00**, to bear interest at the statutory post-judgment rate of 5.51%.
