**JUDGMENT AND ORDER ON
MOTION TO ENFORCE**
(July 16, 2026 Hearing)

This matter came before Commissioner Russell Minas on July 16, 2026 on the commissioner's pro se calendar for a hearing on Petitioner's Motion to Enforce. Petitioner appeared and was represented by attorney Dilllon Harrington on a limited scope basis for this hearing only. Respondent appeared and was represented by attorney Nima Kian on a limited scope basis for this hearing only. Having reviewed the file and considering the input of those present, and for the reasons stated on the record.

IT IS HEREBY ORDERED

1. Petitioner is awarded judgment against Respondent in the amount of \$6,934.36 representing child support arrearages through June 2026.
2. Respondent is found in contempt for unerpayment of child support. The sanction for contempt is 5 days jail and a \$500 fine. The sanctions are stayed and Respondent is provided an opportunity to purge his contempt by making timely ongoing child support payments for the next six months. If Respondent purges contempt the sanction will not be imposed. If Respondent fails to purge contempt Petitioner may file a motion requesting that the stay be lifted and that the sanctions be imposed.
3. Upon Petitioner providing proof that the Rocky Mountain Power bill was paid off by her, within 30 days Respondent shall reimburse Petitioner for 50% of the amount Petitioner paid. There is no finding of contempt on this issue.
4. With respect to alleged parent-time withholding, Petitioner is awarded four (4) days of make-up time to be subtracted from Respondent's next summer parent-time. The issue of

contempt is certified for alleged deliberate parent-time withholding for an evidentiary hearing before Judge Johnson.

5. Respondent is found in contempt for communicating with Petitioner outside of Our Family Wizard (OFW), in violation of Paragraph 19 of the Decree of Divorce. Respondent is sanctioned to five (5) days jail and a \$500 fine, concurrent with the sanctions imposed for non-payment of child support. The sanctions are stayed and Respondent is provided an opportunity to purge his contempt by using OFW consistent with the decree for the next six months, and by completing 16 hours of community service within the next sixty (60) days. If Respondent purges contempt the sanction will not be imposed. If Respondent fails to purge contempt Petitioner may file a motion requesting that the stay be lifted and that the sanctions be imposed.

6. All other issues are reserved and may brought back before te court via separate motion.
