The court decrees:

Divorce

1. Jonquill Christine Gomez is granted a divorce based on the Declaration of Jurisdiction and Grounds signed by Jonquill Christine Gomez. The divorce will become final upon entry of the divorce decree.

2. **Jonquill Christine Gomez** and **Jose Ramon Gomez Casas** do not have any children together.

Alimony Payment

20. **Jose Ramon Gomez Casas** will pay **Jonquill Christine Gomez \$2,060.00** in alimony each month.
21. Alimony will start the month immediately following entry of the divorce decree.
22. The payment schedule will be:
- one half by the 5th day of each month, and
 - the other half by the 20th day of each month.
23. Alimony not paid by the 5th day of the month is past due on the 6th day of the month. Alimony not paid by the 20th day of the month is past due on the 21st day of the month. If the Office of Recovery Services is used to collect child support then ORS may also collect alimony and their payment schedule will be followed.
24. **Jose Ramon Gomez Casas's** alimony obligation will end the earliest of the following:
- **1** years and **9** months.
 - If **Jonquill Christine Gomez** dies.
 - If **Jonquill Christine Gomez** remarries.

Retirement money

25. The parties do not need a court order about retirement money.

Duty to sign documents

26. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)

Name after divorce

27. **Jonquill Christine Gomez** changed **her** name when the parties married. **Jonquill Christine Gomez's** name will be **Jonquill Christine Garner** after the divorce.
