## Divorce

### Duty to sign documents

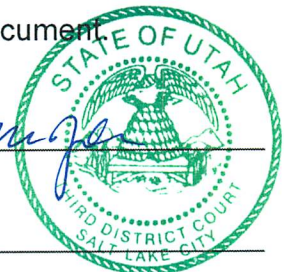
