Divorce

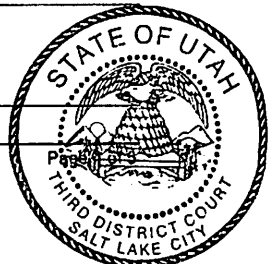

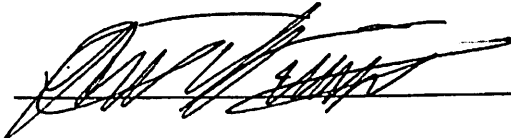

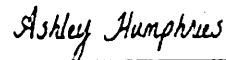
