Pursuant to the Court's Findings of Fact and Conclusions of Law, incorporated herein by this reference, and after having reviewed the documents in this matter and determined that the Stipulated Settlement Agreement between Petitioner and Respondent is fair and reasonable and after having been fully advised in the premises,

IT IS HEREBY ORDERED AND DECREED AS FOLLOWS:

1. **Jurisdiction and Marriage Relationship.** Petitioner, Jeffrey D. Pincock and Respondent Cynthia M. Lee are husband and wife, having been married on February 5, 2025 in Salt Lake City, Utah. The parties separated May 25, 2026. Jeffrey is an actual

and bona fide resident of Salt Lake County and has been for more than three months prior to the commencement of this action.

2. **Termination and Grounds.** Jeffrey is awarded a Decree of Divorce from Cynthia upon the grounds of irreconcilable differences divorcing and dissolving all bonds of matrimony heretofore existing between Jeffrey and Cynthia. The Decree of Divorce shall become absolute when signed by the Court.

3. **Marital Child.** The parties have no minor children between them, and none are expected.

4. **Personal Property.** The parties have divided their personal property to their satisfaction. Each party is awarded the property that is currently in their possession. Petitioner is specifically awarded the Jetta vehicle and shall remove the Respondent's name from the vehicle.

5. **Real Property.** There is no real property which needs division by the Court.

6. **Order on Debts.** Each party is ordered to be responsible for any debts in their individual name and any debts associated with property in their possession.

7. **Notice to Creditors Regarding Debts.** As authorized by U.C.A. §81-4-406(4), the parties are ordered to notify respective creditors or obliges, regarding the divisions of debts, obligations, or liabilities herein and the parties separate, current addresses.

8. **Alimony.** Neither party is ordered to pay to the other any alimony, now or in the future.

9. **Attorney's Fees.** Each party shall pay their own attorney fees and costs of court in this matter.

10. **Financial Accounts.** Each party is awarded their own individual financial account(s) free and clear of any claim by the other.

11. **Retirement Accounts.** Each party is awarded those retirement accounts in their individual name free and clear of any claim from the other.

12. **Miscellaneous.**

a. Each party is restrained and enjoined from harassing, threatening, or maliciously contacting the other, their employers, or family in person, by phone, writing, or social media.

b. Petitioner and Respondent are jointly ordered to cooperate with each other and to execute and deliver any and all documents necessary to effectuate the terms and conditions of any divorce decree entered in this action.
