This matter came before the Court on Defendants White Glass Lending, LLC, Aclaime Credit Strategies Funds, LP, AMF Holdings, LLC, and Keith Crandall's Motion to Dismiss for Failure to Prosecute (the "Motion"), which was filed on June 30, 2026. (Dkt. No. 20.) Having considered the Motion, having reviewed the pleadings and papers on file with the Court, and having found good cause therefor, the Court entered its Order Granting Defendants' Motion to Dismiss (the "Order").

Pursuant to Rule 58A of the Utah Rules of Civil Procedure and the Order, THE COURT HEREBY DECREES AND ENTERS JUDGMENT in favor of the Defendants, and against the Plaintiffs Enzo Rossi and Nina Rossi, as follows:

1. The Plaintiff's Complaint, all of Plaintiffs' claims, allegations, and causes of action asserted therein, and this matter generally, are hereby dismissed.

2. After entry of this Judgment, the Defendants may timely file a motion for attorneys' fees under Rule 73, as well as a verified memorandum of costs under Rule 54, of the Utah Rules of Civil Procedure, to augment this Judgment. Otherwise, the Judgment shall be final as entered.
