Consistent with the Court's Order Granting Plaintiff's Motion for Summary Judgment, entered concurrently herewith, and the Court having granted summary judgment in favor of Plaintiff and against Defendant, **JUDGMENT IS HEREBY ENTERED** in favor of Plaintiff Jeral R. Hudson and against Defendant William J. Cimikoski, Jr., as follows:

1. Principal in the amount of **\$50,000.00**;
2. A late fee accruing at the contractual rate of **\$300.00 per day** from December 18, 2025 until the Judgment is paid in full, which as of July 10, 2026 totals **\$61,500.00** (205 days at

\$300.00 per day), and which continues to accrue at \$300.00 per day from and after July 10, 2026 until the Judgment is paid in full;

3. Post-judgment interest on the total amount of this Judgment at the applicable statutory rate, see Utah Code § 15-1-4, until the Judgment is paid in full; and

4. Reasonable attorneys' fees pursuant to the parties' contract, in an amount to be determined by the Court upon a declaration of attorneys' fees to be submitted by Plaintiff's counsel, which amount, once determined, shall be added to and included within this Judgment.

5. Plaintiff's costs of court in the amount of \$375.00, as allowed by Utah R. Civ. P. 54(d).

Accordingly, the total Judgment entered in favor of Plaintiff and against Defendant as of July 10, 2026, is **\$111,500.00**, consisting of \$50,000.00 in principal and \$61,500.00 in accrued late fees, together with (a) a continuing late fee of \$300.00 per day from and after July 10, 2026 until the Judgment is paid in full; (b) post-judgment interest at the applicable statutory rate until paid in full; and (c) reasonable attorneys' fees to be determined upon the declaration of Plaintiff's counsel.

This Judgment shall accrue post-judgment interest at the statutory rate until paid in full.
