Pursuant to the Order from May 20, 2026, Evidentiary Hearing, entered by this Court on June 30, 2026, the Court, having reviewed the Affidavit of Attorney Fees and Costs and Detailed Accounting of Attorney Fees filed by Petitioner on May 26, 2026, and for good cause appearing, hereby enters the following:

ORDER AND JUDGMENT:

1. The Court orders that Petitioner, Christopher Fischer, is awarded reasonable attorney fees and costs, not to exceed \$10,000, related to the Respondent's contempt

for interfering with Mr. Fisher's parent time in May, June, and September of 2025, which was before the Court at the May 20, 2026, Hearing.

2. Judgment is hereby entered in favor of the Petitioner, Christopher Fischer, against the Respondent, Cheryl Baird, in the amount of \$10,000.

3. Judgment is also entered in favor of the Petitioner against the Respondent in the amount of \$400.51 for the cost for reimbursement of his Airbnb fees from June 15 to June 17.

4. The total judgment entered in favor of the Petitioner, against the Respondent, is \$10,400.51

5. Pursuant to U.C.A. §15-1-4(3)(a), the statutory post judgment interest rate of 5.51%, shall be applied to the judgment beginning 30 days after the entry of this Order and Judgment, until the judgment has been satisfied.

6. If the judgment is not satisfied within 60 days after the entry of this Order and Judgment, the Respondent shall be responsible to pay after-accruing costs and attorney fees expended by Petitioner in the collection of said Judgment.
