DEFAULT JUDGMENT

In this action, the defendants Gibson's Green Acres, LLC and Ron Gibson (hereinafter collectively "defendants"), having been regularly served with process, and having failed to appear and answer plaintiff Intermountain Farmers Association ("IFA")'s complaint filed herein, the legal time for answering having expired, and the default of the defendants in the premises having been duly entered according to law, now upon the

application of IFA to the above-entitled court, judgment is hereby entered against defendants in pursuance of the prayer of said complaint.

Wherefore, it is ordered, adjudged, and decreed that IFA recover from defendants the sum of \$103,978.99, together with \$2,331.00 in attorney fees, together with \$375.00 in filing fees, together with \$267.50 in service costs, together with prejudgment interest in the amount of \$7,691.60 in accrued interest from February 21, 2026 through July 21, 2026, at the contract rate of 18% per annum, for a total judgment of **\$114,644.09**.

It is further ordered that this judgment may be augmented in the amount of interest at the rate of 18% per month continuing from July 22, 2026 until paid in full, and also augmented with reasonable costs and attorney fees incurred in collecting said judgment by execution or otherwise as may be established by affidavit. Pursuant to Utah R. Civ. P. 54(b) and 62, this judgment constitutes a final judgment, there being no just reason for delay.
