On May 21, 2026 the parties appeared before the Honorable Judge Laura Scott for a Bench Trial. Petitioner, Rebecca Buck-Rhodes, was present and was representing herself. Respondent, Anthony Rhodes, was present with his counsel of record, Daniel L. Heaps.

After receiving evidence and testimony from the parties, and based on the Findings of Fact concurrently filed herewith, makes the following orders:

1. The parties are granted a divorce based on irreconcilable differences.

2. The wedding debt of \$5,750 attributed to Anthony in Schedule C2 of the Prenuptial Agreement had been paid by the time of separation and Anthony is no longer responsible for it.
3. Anthony is fully responsible for the child custody expenses which were paid for with Rebecca's Citi Credit Card in the amount of \$14,740.
4. The Court awards Rebecca \$50 for a reimbursement for medical expenses paid to Generational Health on behalf of Anthony.
5. The Court declines to award Rebecca any money from Anthony's personal injury settlement proceeds.
6. Anthony is ordered to return the ring within 2 weeks of the trial, which was a gift to Rebecca.
7. Each party will retain possession of one paddleboard.
8. The Court awards Rebecca \$1,500 in attorney fees related to the improper bad-faith assertion of the unenforceability of the Prenuptial Agreement.
9. Anthony has 30 days to pay the total money judgment of \$17,290, at which point it will be reduced to a judgment.
10. If judgment is entered, interest may accrue at the statutory rate pursuant to Utah Code Ann. 15-1-4.
