Petitioner Jordan Carli Burr (“Jordi”)’s *Counter Motion to Enforce Order and for Sanctions* came on for hearing on June 3, 2026, the Honorable Domestic Commissioner Michelle Blomquist presiding. At the June 3, 2026 hearing, Jordi was present and represented by her counsel of record, James M. Hunnicutt. Respondent Randon Michael Burr (“Mike”) was present and represented by his counsel of record, Jason Fuller. As reflected in the *Order from June 3, 2026 Hearing* entered on June 29, 2026, the Commissioner granted Jordi’s motion and, among other things, awarded Jordi \$9,258 for unpaid past due base child support and \$7,802.13 for unpaid past due alimony.

Based on the foregoing, it is hereby ORDERED, ADJUDGED, and DECREED that Petitioner Jordan Carli Burr is awarded this JUDGMENT, as follows: a monetary award against Respondent Randon Michael Burr in the amount of:

- a. Nine Thousand Two Hundred Fifty-Eight Dollars and No Cents (\$9,258.00) for three months of unpaid past due base child support from December 2025 through February 2026; plus
- b. Seven Thousand Eight Hundred Two Dollars and Thirteen Cents (\$7,802.13) for seven months of unpaid past due alimony from December 2025 through June 2026.
