Additional provisions

11. The parties will adhere to the following additional provisions:

a.

Additional Provision: I respectfully request that the court grant me legal ownership of all six household cats listed in the "Other Personal Property" section: Zuko, Azula, Iroh, Mabel, Dipper, and Soos. These pets have been an important part of my life and home. I am currently in possession of Azula, Mabel, Dipper, and Soos. I further request that the court order the return of Zuko (gray tabby, 11 years old) and Iroh (gray tabby, 10 years old), who are currently in the possession of my spouse, so that they may be reunited with their longtime feline companions. I respectfully request that the return of Zuko and Iroh be completed within 60 days of the date the divorce decree is signed.

b.

Additional Provision: Each party shall retain sole ownership of their respective retirement accounts, including but not limited to 401(k), pension, IRA, or other retirement-related funds or benefits currently in their name. No division, transfer, or sharing of retirement accounts shall occur between the parties, and each party shall waive any claim to the other's retirement assets.

c.

Additional Provision: Each party shall be solely responsible for any debts or liabilities incurred in their own name, whether before or after the filing of this divorce. Neither party shall be held liable for the debts of the other, and no division or equalization of personal debts shall be required.


Duty to sign documents

12. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)

Name after divorce

13. **Sylvia Mae Guldenschuh** changed her name when the parties married. **Sylvia Mae Guldenschuh's** name will be **Sylvia Mae Turner** after the divorce.
