The court decrees:

**Divorce**

1. Tamilyn Ropelato is granted a divorce based on the Declaration of Jurisdiction and Grounds signed by Tamilyn Ropelato. The divorce will become final upon entry of the divorce decree.

7. The parties do not need a court order about retirement money.



### Duty to sign documents


