Being fully advised in the premises, based on its statutory authority and in equity, hereby **ORDERS, ADJUDGES, AND DECREES** as follows:

1. **Grant of Divorce:** The bonds of matrimony currently existing between Petitioner and Respondent are hereby dissolved, and the parties are granted a final Decree of Divorce.
2. **Incorporation by Reference:** The Findings of Fact and Conclusions of Law signed by this Court, as well as the Stipulation and Property Settlement Agreement signed by the

parties and filed with this Court on April 6, 2026, are hereby approved, adopted, and incorporated into this Decree of Divorce by reference as if fully set forth herein.

3. Binding Effect & Compliance: The parties shall be mutually bound by the terms outlined within the incorporated documents and are hereby ordered to comply with all provisions, obligations, and directives set forth in the Findings of Fact and Conclusions of Law.

4. Final Resolution: This Decree serves as a final resolution of all claims between the parties regarding the dissolution of their marriage.
