The court decrees:

**Divorce**

1. Jessica Ries is granted a divorce based on the Declaration of Jurisdiction and Grounds signed by Jessica Ries. The divorce will become final upon entry of the divorce decree.

Children (Utah Code 81-6-101(7))

2. **Jessica Ries** and **Zachary Brandley** do not have any children together.

7. The parties do not need a court order about retirement money.

### Duty to sign documents

8. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)


