1. Judgment is hereby entered in favor of the Plaintiff and against the Garnishee for the amount due and owing to Plaintiff for the amount of the Default Judgment entered June 13,

2025, which is \$24,696.14, together with post-judgment interest at the statutory rate from the date hereof, until paid in full;

2. Judgment is hereby entered in favor of the Plaintiff and against the Garnishee for attorney's fees of \$480.00 and costs of \$45.00;

3. The total judgment awarded to the Plaintiff against the Garnishee, excluding interest is \$25,221.14; and

4. It is further ordered that this judgment may be augmented in the amount of reasonable costs and attorney's fees expended in collecting the judgment by execution or otherwise, as allowed by statute or rule and approved by the Court.
