COMES NOW, Petitioner, JEREMY FREDRICKSEN, by and through counsel, Ron K.

Nichols of the law firm KAUFMAN, NICHOLS & KAUFMAN and Respondent, KRISTIN FREDRICKSEN (AKA FERREIRA), the court being fully advised on the pleadings and having previously entered its written Findings of Facts and Conclusions of Law: NOW THEREFORE IT IS ORDERED, ADJUDGED AND DECREED AS FOLLOWS:

1. Petitioner, Jeremy is a bona fide resident of Weber County, State of Utah, and was so for at least three (3) months prior to the commencement of this action.
2. Respondent, Kristin is a resident of California.

3. Jeremy and Kristin were married on January 14, 2005, in the city of Ogden, State of Utah.
4. The parties' divorce shall be granted on the grounds of irreconcilable differences because the parties have been unable to resolve their marital problems, making continuation of the marriage impossible
5. No children have been born as issue of this marriage and none are expected.
6. No alimony is awarded to either party as they have been living separately and on their own for over 20 years. Therefore, no alimony shall be awarded to either party now or in the future.
7. The parties do not have any business interests.
8. The parties do not have any real property at issue in this marriage.
9. The parties shall be awarded the separate, personal property that he or she acquired prior to the marriage.
10. All personal property acquired by the parties during the course of the marriage have been equitably divided.
11. The parties shall be awarded their own retirement in their own name with no claim by the other party now or in the future.
12. There are no outstanding marital debt as they have been separated for over 20 years. If there is any outstanding debt, the parties shall be equally responsible for said marital debt.
13. The parties should be solely responsible for any debts in their individual name, including but not limited to any debts incurred after the parties' separation on or about January 2006.

14. The Respondent, Kristin shall be allowed to restore use of her former name, if she so chooses.

15. Both parties shall be duly ordered to execute and deliver all documents necessary to effectuate the terms in the Decree of Divorce.

16. The parties shall be permanently restrained from annoying, bothering, or harassing each other at any time and at any place.

17. In the event that either party fails to perform his or her obligations under the Decree of Divorce, the parties should be required to pay all costs and attorneys' fees of the other party incurred for enforcing the terms of the Divorce Decree.
