WHEREFORE, the Court has reviewed the Findings of Fact and Conclusions of Law, Stipulation and Settlement Agreement, and previous pleadings submitted to the Court. Based thereon, it is hereby ordered, adjudged and decreed as follows:

1. Residency: Petitioner and Respondent are bona fide residents of Weber County, State of Utah, and have been for at least three (3) months immediately prior to the filing of this action.
2. Jurisdiction is proper in this Court pursuant to Utah Code Ann. § 78A-5-102.

3. Venue is proper in this Court pursuant to Utah Code Ann. § 81-4-203.
4. Marriage Statistics: The parties were married on or about July 9, 2025, in Hooper, Weber County, Utah, and are presently married.
5. Grounds: Since the marriage of the parties, there have arisen irreconcilable differences between the parties, making it impossible to continue the marital relationship.
6. Children: The parties do not share any minor children.
7. Alimony: The parties agree that neither party will pay alimony to the other now and forever.
8. The parties have a mutual duty to hold harmless and indemnify the other from any debt or harm associated with the foregoing awards of vehicles and personal property.
9. The parties stipulate and agree that each party shall be awarded any and all personal property items in their current respective possession. The parties further waive any and all claims to the other's personal property.
10. The parties shall be entitled to keep their personal possessions brought into the marriage.
11. Real Property: The parties did not acquire any real property during the marriage.
12. Assets: The parties do not have any other joint assets.
13. Retirement: The parties shall each be entitled to any retirement accounts in their own name.

14. Debt: The parties have no shared debt. Both parties agree to be responsible for all of the debt incurred in their own name, including personal credit cards.

15. The parties should cooperate with each other to file their taxes for the 2025 tax year. Commencing the 2026 tax year, the parties should file their taxes separately.

16. Both parties should be mutually restrained from bothering, annoying, harassing, stalking, or threatening the other party, electronically or in person.

17. Both parties should be mutually restrained from entering the residence of the other party without permission from that party.

18. Both parties should be mutually restrained from permitting third parties to do what they themselves are prohibited from doing under this paragraph and should have the affirmative duty to use his or her best efforts to prevent third parties from such violation.

19. Attorney's Fees and Costs: Each party should be ordered to assume his or her own costs and attorney's fees incurred in this action, if any.
