The court decrees:

Divorce

8. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)

Name after divorce

9. **Carol E Fielding** changed **her** name when the parties married. **Carol E Fielding's** name will be **Carol E Sparto** after the divorce.
