The parties also agree that the Petitioner shall have sole possession and responsibility for the Siberian Husky and German Shepherd for the first twelve (12) months following the date of this agreement, including full authority over veterinary care, housing, and travel during that period. Respondent may request a transfer of ownership after twelve (12) months. Any future transfer shall be determined by mutual written agreement of the parties, which shall not be unreasonably withheld, taking into consideration the dogs' health, stability, best interest, and Respondent's demonstrated ability to provide appropriate care, housing, and financial support. The parties agree that a transfer shall not be unreasonably withheld if Respondent can provide a suitable living situation, including adequate space and safety, such as a residence with a backyard appropriate for the dogs. Duty to sign documents

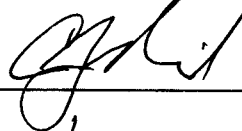
