Divorce

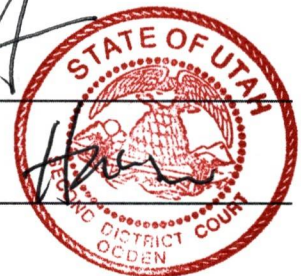
