**ORDER AND JUDGMENT
RE: ATTORNEY FEES**

On May 15, 2026, the Court conducted a hearing on Petitioner Michelle Rose Hawkins' *Motion for Award of Costs and Attorney Fees*, filed August 13, 2025. Petitioner's counsel, Andrew S. Rawlings, was in attendance, and Respondent Justin Eugene Hawkins was in attendance, representing himself *pro se*.

THE COURT, having considered the relevant documents and the parties' respective arguments, being well-informed in the premises, and for good cause appearing,

HEREBY FINDS, ORDERS, and ADJUDGES as follows:

1. In her Petition to Modify, filed April 1, 2025, Petitioner included a request that Respondent be solely responsible for Petitioner's attorney fees incurred in connection with said Petition to Modify.

2. Respondent was appropriately served with a summons and a copy of the Petition to Modify, but he filed no answer thereto, resulting in the entry of his default.

3. However, the Findings of Fact and Conclusions of Law and the Modification Order that were entered as a result of Respondent's default did not include an attorney fees provisions, which is why Petitioner filed her August 13, 2025 Motion.

4. It is fair and reasonable that the parties share evenly the attorney fees incurred by Petitioner in connection with the Petition to Modify.

5. Petitioner incurred attorney fees totaling \$3,037.00.

6. Therefore, judgment is hereby entered against Respondent Justin Eugene Hawkins, in Petitioner Michelle Rose Hawkins' favor, in the amount of ONE THOUSAND FIVE HUNDRED EIGHTEEN U.S. DOLLARS AND FIFTY CENTS (\$1,518.50).

7. The Office of Recovery Services shall collect on this judgment, in addition to the collection of child support in this case.
