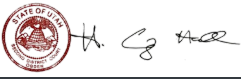
Duty to sign documents

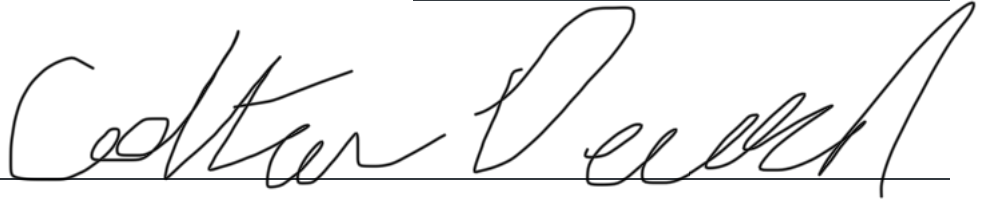

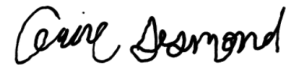
