THIS MATTER having come on before the Honorable Catherine Conklin, Judge presiding, papers appearing to be in order; Respondent was duly served with a copy of the Verified Petition and a copy of the Summons; wherein a Default Certificate having been entered on May 21, 2026; John Bettis having been sworn and testified and the Court having been fully informed in the premises, and having made its Findings of Fact and Conclusions of Law separately stated in writing,

NOW THEREFORE,

IT IS HEREBY ORDERED, ADJUDGED AND DECREED as follows:

1. **Divorce.** The parties are granted a mutual Decree of Divorce from each other on the grounds of irreconcilable differences, same to become final upon signing and entry.

2. **Alimony**: Neither of the parties is awarded any rights or interest in alimony, past, present or future as each party is capable of supporting themselves.

3. **Retirement**: Each party is awarded any retirement benefits in their name, free and clear of any interest in the other party.

4. **FREGA Stock**. Linda Bettis is awarded her shares of stock and similar types of negotiable instruments with Frega, free and clear of any interest in John Bettis.

5. **John Bettis's Personal Property**. John Bettis is awarded those items of personal property currently in his possession, together with his personal belongings and effects.

6. **Linda Bettis's Personal Property**. Linda Bettis is awarded those items of personal property currently in her possession, together with her personal belongings and effects.

7. **Marital Debts And Obligations**: That responsibility for the parties' debts is ordered as follows:

(a) John Bettis is to pay those debts in his name, and to indemnify, defend and hold Linda Bettis harmless therefrom.

(b) Linda Bettis is to pay those debts in her name, including her student loan and to indemnify, defend and hold John Bettis harmless therefrom

8. **Real Property Division**: The parties have acquired no interest in real property.

9. **Attorney Fees**: Each party is to pay their own attorney's fees and costs.

10. **Miscellaneous Provisions**: Each party is ordered to execute and to deliver to the other party such documents as are required to implement the provisions of the Decree of Divorce hereinafter to be entered by the court and to use all due diligence and reasonable efforts to comply with each of the terms and conditions of that decree.
