Based upon the Order Granting Joint Motion to Enter Judgment that was entered in the above-captioned matter:

1. Judgment is hereby entered in favor of the Plaintiff America First Federal Credit Union (“America First”) against Defendants Rafael Castillo and Lilibeth Lopez-Mendoza (“Defendants”), jointly and severally, for the amount due and owing under the Note, as such term

is defined in the Complaint, which is \$21,481.68, plus interest at the contract rate of 11.49% per year from February 6, 2026, until paid in full;

2. Judgment is hereby entered in favor of America First and against the Defendants, jointly and severally, for attorney's fees of \$1,654.00 and costs of \$560.00;

3. The total judgment awarded to the Plaintiff, excluding prejudgment and post-judgment interest, is \$23,695.68; and

4. It is further ordered that this judgment may be augmented in the amount of reasonable costs and attorney's fees expended in collecting the judgment by execution or otherwise, as allowed by statute or rule and approved by the Court.
