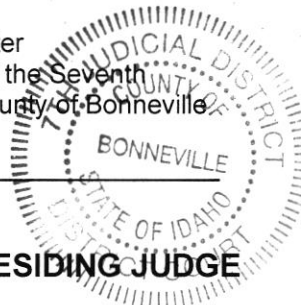

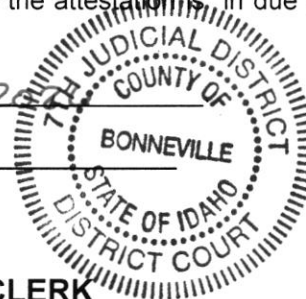

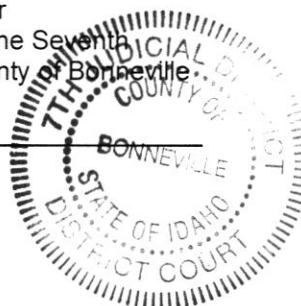

1. Judgment is hereby entered against TRAVIS DON HOKANSON and SANDRA A. HOKANSON aka Sandra A. The current Judgment amount is calculated and itemized as follows:

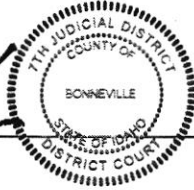
