Based upon the Joint Motion for Entry of Judgment filed by Plaintiff America First Federal Credit Union (“Plaintiff”) and Defendant Delbert E. Driscoll (the “Defendant”), IT IS HEREBY ORDERED, ADJUDGED AND DECREED that:

1. Judgment is hereby entered in favor of the Plaintiff and against Defendant for the amount of \$20,399.12 owed under the Visa Card identified in the Complaint, together with interest at the contract rate of 16.24% per year from June 11, 2026, until paid in full;

2. Judgment is hereby entered in favor of the Plaintiff and against Defendant for the amount of \$831.79 owed under the LOC identified in the Complaint, together with interest at the contract rate of 18% per year from June 11, 2026, until paid in full;

3. Judgment is hereby entered in favor of the Plaintiff and against Defendant for the amount of in the amount of \$15,041.96 for the amount due under the Negative Shares, together with prejudgment interest at the statutory rate of 10% per year from June 11, 2026, until the date hereof and post-judgment interest thereafter at the statutory rate until paid in full.;

4. Judgment is hereby entered in favor of the Plaintiff and against the Defendant, for attorney's fees of \$1,326.00 and costs of \$375.00;

5. The total judgment awarded to the Plaintiff against Defendant, excluding prejudgment and post-judgment interest is \$37,973.87; and

6. This judgment may be augmented in the amount of reasonable costs and attorney's fees expended in collecting the judgment by execution or otherwise, as allowed by statute or rule and approved by the Court.
