Re: Shared Master Offense Table (SMOT) Refinements from 2026 Legislative Session

2026 Legislative Session Updates

Among the 541 bills that passed during the 2026 legislative session, the legislature enacted 62 bills that result in changes to — or addition of — offenses listed in the Shared Master Offense Table. While most of the changes from the 2026 session will be effective on **May 6, 2026**, several legislative items have delayed effective dates, as follows:

- **July 1, 2026** — HB0265, HB0423, HB0473, and SB0323.
- **January 1, 2027** — HB0040, HB0054, HB0447, and SB0210.

Those bills with effective dates in July and January are **indicated as such** in the “Comments” column of the spreadsheet that accompanies this memo.

Note that 30% of the 2026 changes result from HB0301 (the recodification of Title 58 controlled substance violations). The spreadsheet indicates the action taken for each SMOT entry:

- **ADD** — These are offenses that were not previously included in SMOT, but have become necessary due to legislative changes **or** were existing offenses that were discovered as bills were reviewed;
- **EDIT** — These were existing SMOT entries where the violation code, the description, and/or the level of offense were modified. For each “**EDIT**” entry the changed details are indicated in **bold underlined** text.
- **REMOVE** — These offense codes have been either completely eliminated **or** have been replaced with accompanying “**ADD**” entries.
