Dear Committee Members:

The last meeting of the Committee for the current season will be held on Wednesday, June 10, 1992, beginning at 4:00 p.m. As usual, the meeting will be held in the Council Room of the Administrative Office of the Courts, 230 South 500 East, Salt Lake City, Utah.

I ask that you be prompt so that we can conclude our work within the usual two hours. We have a publication deadline looming, and it would be wonderful if we could conclude all of the following business:

1. We will consider a final draft of changes to Rule 69, which I enclose. Brad Baldwin and his energetic subcommittee are to be complimented on plowing through this material so quickly. I hope that we can give final approval to this rule change at our June 10 meeting.

2. We will consider a final draft of changes to Rule 35, and particularly 35(a), which I enclose. You will note that I have also enclosed a proposed committee note for your consideration. There was a good deal of discussion about this committee note at our April meeting, and Allan Larsen offered to propose a substitute committee note, which he has set forth in his April 9, 1992 letter, enclosed. Again, I hope that we will give final approval to the rule and, if possible, to a proposed committee note at our June 10 meeting.

3. We will take up proposed changes to Rule 65B. You will recall that at our last meeting, Kirk Torgenson proposed a number of changes to subparts (b) and (c) to which we agreed in principle. Kirk has drafted those changes in a proposed series of amendments, which I enclose. I invite Kirk to come to our meeting once again.

I look forward to seeing all of you on June 10, 1992.
