Here is Michael Drechsel's explanation from page 29 of his Legislative Synopses 2024:

Note: Under these revised statutes, a petitioning individual is only required to indicate whether they are registered on "the state's Sex and Kidnap Offender Registry." On July 1, 2024, SB0023 will merge the Sex and Kidnap Offender Registry with the Child Abuse Registry into a single registry referred to as the "Sex, Kidnap, and Child Abuse Offender Registry" (i.e., "the state's Sex and Kidnap Offender Registry" will no longer exist). Currently Utah Code section 77-43-105(7) creates an outright ban on a name change for an individual registered on the child abuse registry. SB0023 repeals Utah Code section 77-43-105 and does not import that prohibition into the newly merged statutory scheme. Two observations about these changes:

- it is clear that starting on July 1, 2024, an individual required to register as a "child abuse offender" will no longer be prohibited from seeking a name change; and
- it is unclear whether an individual required to register as a "child abuse offender" will have to indicate that fact to the court as part of the name change or sex designation petition, because this new requirement to indicate registration status is limited to individuals required to register on "the Sex and Kidnap Offender Registry."
