Farmington, <u>Layton</u> and Bountiful courthouses into one facility. Feasibility study to be completed in FY23.




**Manti Sixth District Courthouse**











## Space Utilization Studies of All Three Existing Facilities



# Capital Improvement Projects Completed or in Progress FY23

- FY23 prioritized 32 projects approved by Legislature with a total funding of \$6.9M with 79% of projects complete YTD.
- Notable Projects from FY23 –
   Vernal security system upgrade,
   St. George carpet replacement,
   Matheson HVAC upgrades,
   Richfield interior finishes upgrade and Cedar City exterior concrete replacement

# Capital Improvement Projects Approved for FY24

- Top 12 of 78 prioritized projects approved by the Legislature for FY24 with a total funding of \$7.7M.
- Notable Projects in FY24 Build out of 2 Provo shelled courtrooms and Matheson AV upgrades for 14 courtrooms
