Rule 7A. Pick up Orders.

On verbal request from a probation officer or other authorized individual a pick up order may be issued telephonically during nonbusiness hours or under exigent circumstances when it appears necessary for the protection of the community or the minor and shall be supported by an affidavit from the requesting authority the next court business day.

Rule 7A is adopted pursuant to the expedited rulemaking provisions contained in Rule 11-101(6)(F) of the Supreme Court Rules of Professional Practice.
