<b>II. Continued Discussion of Rule 19 and Rule 19A</b>	JUDGE LINDSLEY
<p>Judge Lindsley discussed the latest drafts of Rules 19, 19A, 19B, and 19C. She reviewed responses from her survey of juvenile judges regarding whether the rule should contained a provisions requiring Requests to Submit for Decision. Responses were mixed, although the majority of those who use it said the Request is not needed for stipulated motions. Judges also mentioned that without the Request, it may be difficult to determine when the time period starts for reporting of cases under advisement as required by CJA Rule 3-105(3)(k). Mikelle Ostler suggested that the language in Rule 19A include the URCP 7(g) list of what the filer must include in the Request to Submit. Judge Lindsley also discussed the ability to link related documents in CARE.</p> <p>The rule pertaining to Requests to Submit will also apply in delinquency proceedings. A lengthy discussion followed regarding whether different procedures are required for oral versus written</p>
