

1 **Rule 14-413. CLE Accreditation for qualified audio and video presentations,**  
2 **webcasts, computer interactive ~~telephonic~~ programs, writing, lecturing, teaching,**  
3 **public service, and ~~live-verified~~ attendance.**

4 (a) ~~Permissible Elective CLE credit. Self Study CLE Credit~~ Elective CLE credit will be  
5 allowed for Accredited audio and video presentations, webcasts ~~or~~, computer  
6 interactive ~~telephonic~~ programs, writing, lecturing, teaching, and service in accordance  
7 with the following.

8 (1) One hour of ~~Self Study~~ Elective CLE credit will be allowed for viewing and/or  
9 listening to 60 minutes of audio or video presentations, webcasts, or computer  
10 interactive ~~telephonic~~ programs in accordance with Rule 14-408(a).

11 (2) Upon application to the Board, the Board may grant a waiver, permitting a  
12 lawyer or paralegal practitioner on active status to obtain all required hours of credit  
13 through ~~Self Study~~ Elective CLE, if the lawyer or paralegal practitioner:

14 (A) does not reside in Utah; and

15 (B) is engaged in full-time volunteer work for a religious or charitable  
16 organization.

17 (b) ~~Writing and publishing an article. Self Study~~ Elective CLE is allowed for writing  
18 and publishing an article in a legal periodical in accordance with the following.

19 (1) To be eligible for any credit, an article must:

20 (A) be written to address a lawyer audience;

21 (B) be at least 3,000 words in length;

22 (C) be published by a recognized publisher of legal material; and

23 (D) not be used in conjunction with a seminar.

24 (2) Three ~~Self Study~~ Elective CLE credit hours will be allowed for each 3,000 words  
25 in the article. An application for Accreditation of the article must be submitted at

26 least 30 days prior to reporting the article for credit. Two or more authors may share  
27 credit obtained pursuant to this paragraph in proportion to their contribution to the  
28 article.

29 (c) **Lecturing, teaching, or delivering a paper or speech at a meeting.** ~~Self Study~~  
30 Elective CLE credit is allowed for lecturing in an Accredited CLE program, part-time  
31 teaching by a lawyer or paralegal practitioner in an approved law school, or delivering  
32 a paper or speech on a professional subject at a meeting primarily attended by lawyers,  
33 paralegal practitioners, legal assistants, or law students in accordance with the  
34 following.

35 (1) Lecturers in an Accredited CLE program and part-time teachers may receive  
36 three hours of ~~Self Study~~ Elective CLE credit for each hour spent in lecturing or  
37 teaching as provided in Rule 14-409(a)(1), including participation in panel  
38 discussions.

39 (2) Lecturers in a community outreach capacity, as described in Rule 14-409(a)(2),  
40 may receive one hour of ~~Self Study~~ Elective CLE credit for each hour spent in  
41 lecturing or teaching provided such CLE credit does not exceed four hours for a  
42 Compliance Cycle for a lawyer or two hours for a Compliance Cycle for a paralegal  
43 practitioner.

44 (d) **Full-time law school faculty members.** Full-time law school faculty members may  
45 receive ~~Self Study~~ Elective CLE credit for lecturing and teaching, including  
46 participating as a presenter in a panel discussion, but only for lecturing and teaching  
47 Accredited CLE courses.

48 (e) **Minimum Credit hours of Verified CLE.** Credit is allowed for ~~Live-Verified~~ CLE in  
49 accordance with Rule 14-408(a).

50 (1) A lawyer must obtain a minimum of six Accredited CLE hours, with no  
51 maximum restriction, through Live-Verified CLE.

52 (2) A paralegal practitioner must obtain a minimum of three Accredited CLE hours,  
53 with no maximum restriction, through ~~Live-Verified~~ CLE.

54 (f) **Total allowable hours.** The total of all hours allowable under paragraphs (a), (b), (c),  
55 and (d) of this rule may not exceed six hours during a Compliance Cycle for a lawyer,  
56 nor three hours during a Compliance Cycle for a paralegal practitioner.
