

1 Rule 14-104. Admission to practice law; qualifications, enrollment, oath, and fees.

3 (a) The Board, by delegation from the Supreme Court, is authorized ~~shall have the power~~ to determine the
4 qualifications and requirements for admission to the practice of law and to conduct examinations of
5 applicants; and it shall from time to time certify to the Court those applicants found to be qualified.
6 Qualifications and requirements for admission to the practice of law are ~~shall be as~~ set forth in Chapter 14,
7 Article 7, Admissions.

9 (b) The Board, by delegation from the Supreme Court, is authorized ~~shall have the power~~ to determine the
10 qualifications and requirements for the Licensure of the Licensed Paralegal Practitioners and to conduct
11 examinations of applicants, and it shall from time to time certify to the Court those applicants found to be
12 qualified. Qualifications and requirements for Licensed Paralegal Practitioner licensure are ~~shall be as~~ set
13 forth in Chapter 15, Article 7, Licensure.

15 (c) The ~~approval by the~~ Supreme Court's approval of any person certified for licensure to practice law
16 ~~shall entitle the person~~ him or her to be enrolled in the Bar upon ~~his or her~~ taking an oath to support the
17 Constitutions of the United States and of Utah and to discharge faithfully the duties of an attorney at law,
18 foreign legal consultant, or Licensed Paralegal Practitioner to the best of the person's ~~his or her~~
19 knowledge and ability, and payment of the fee fixed by the Board with the Supreme Court's ~~approval of~~
20 ~~the Court~~, and thereafter, to practice law upon payment of annual or special license fees herein provided,
21 subject to the provisions of this chapter.

23 (d) Upon receiving Board certification ~~by the Board~~ and Supreme Court approval ~~from the Supreme~~
24 ~~Court~~, the applicant must ~~shall~~ pay a fee set by the Supreme Court clerk ~~of the Court~~
25 for a certificate of admission. The state treasurer will retain a portion of the fee, a portion of which shall
26 ~~be retained by the state treasurer~~ as a special fund for the benefit of the Utah State Law Library, to be
27 expended by the Utah Judicial Council. The Supreme Court will set the fee for a certificate of good
28 standing.

30 (e) Roll of licensed lawyers and Licensed Paralegal Practitioners. The Supreme Court clerk ~~of the Court~~
31 will ~~shall~~ keep a roll of the attorneys at law admitted to practice in Utah and Licensed Paralegal
32 Practitioners, which must be signed by each person admitted or licensed before the person ~~he or she~~ is
33 enrolled and receives a ~~his or her~~ certificate of admission to the Bar or license as a foreign legal consultant
34 or Licensed Paralegal Practitioner.
